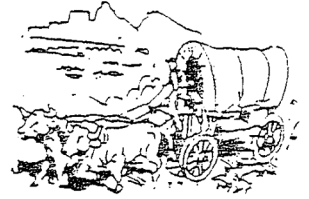

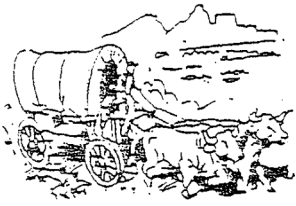

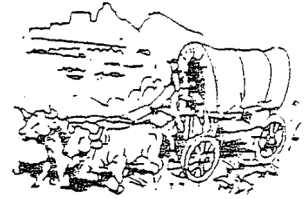

- ✓ **Proof of liability insurance must accompany all new or renewed contracts to secure your location.**
- ✓ **Valid insurance required to set up booths.**
- ✓ In order to secure your same location you must return your **signed application, all fees and proof of insurance by June 30, 2012.** If not received by the above date, then your location will become available to other vendors.
- ✓ The fee is to be paid regardless of your cancellation or prevention of continuing due to any act, event, or catastrophe for which the management or sponsor is not responsible. **Fees are non-refundable.**
- ✓ Stands may be set up on Tuesday, August 14, 2012, **no earlier than 5:30 p.m.**, and may not be removed until 11:00 p.m. on Thursday, August 16, except by special arrangement.
- ✓ The undersigned hereby reserves space for the display and/or sale of items at Old Settlers Days in Hillsboro, Illinois, on August 15-16, 2012.
- ✓ **The selling of guns, knives or weapons of any kind, silly string, stink bombs, snap pops or questionably appropriate items are prohibited.**
- ✓ The Old Settler's Assoc. will not be responsible for any injury or the safety of property of the exhibitors from theft, damage by fire, rain, or accident, or to the exhibitors or their employees, and are released from any liability.
